Message from the Commissioner

Every now and then, I read or hear something that makes me sit up straight. Something that eloquently expresses why data protection is fundamentally about putting people first.



On this occasion it came in the form of a newly published book I started reading, which is also this month's reading recommendation.

The opening gambit is that we have lost sight of what is truly at stake in relation to technological development.

That is pretty damming, but I also think it is true. Equally, we have an opportunity to reframe our conversations and our approach.

If we launch headfirst into a tick box exercise around data protection compliance, there is every chance that we perceive it as an evil necessity and only do the minimum required to get a tick into the box.

If we stop seeing tick boxes and start seeing the faces of the human beings behind the data – including ourselves and our friends and family, we are likely to look at things a little differently.

If we stop seeing the protection of data as something to defend organisations from and start to see it as something we are all entitled to, that is also likely to make us look at things a little differently.

The approach we take at the ODPA is not accidental. It is an approach with the human being at its heart. We want to help encourage better, more human engagement with the framework of legal protections.

This is not an approach that will work for everyone. Some people will never care. Some people are motivated only by the threat of enforcement.

But, I believe that the vast majority of us do care what happens to our private information, what our doctor does with our medical notes, what our bank does with our financial information, what our employer does with our HR file, what the school does with our children's records.

Data protection is simply the setting into statute of those things that we care about and value in our lives. That is the good fortune and privilege of living in a democracy.

We may not give it much thought, but I would encourage you to take a moment to imagine life without these protections.

It gets to the heart of what it is to be human. It is about dignity, autonomy, equality. The next time that data protection elicits an eye-roll or a sigh or a grunt of frustration, take a moment to reflect on these things.

We are responsible for regulating the law. That means dealing openly and accountably with complaints, investigations and enforcement.

It also means working to expand conversations beyond tick box compliance to help us all get the protection of our personal data right.



- We published **new** guidance on <u>Subject Access Requests</u> for data subjects who want to know how to make a subject access request (SAR), what they should receive back, and what to do if they're not happy with what they receive.

- We have **updated** our <u>personal data breach reporting guidance</u>.


