The ODPA has been made aware of a suspected data scraping incident in the Bailiwick in which an online business directory appeared to be scraped by a third party, who then attempted to sell the data.

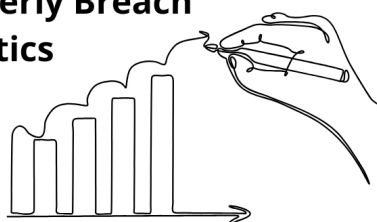

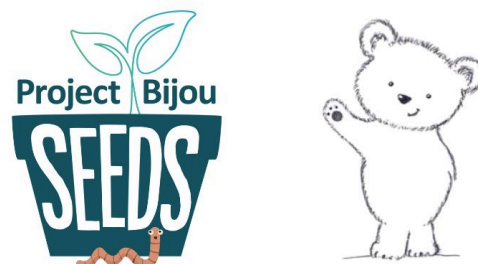
